## Accelerated Interactive Vocational Education Programs©



### **Overview: Design and Perform Cosmetic Tattoo (Micropigmentation) procedures.**

The course is designed to cover all aspects of the performance criteria as set down by the NTIS (National Training Information Service) for the course;  
WRBSS505B: Design and perform cosmetic tattooing (micropigmentation) procedures.

I have broken this into a five module training course designed to give the trainee the basic skills and knowledge to be able to perform a range of Cosmetic Tattooing procedures. To be deemed as competent the trainee must show a knowledge of the anatomy and physiology of the face as it relates to Cosmetic Tattooing, they must show knowledge and skill in the application of relevant legislation and workplace policies and procedures, particularly in regard to infection control and skin penetration. They must be able to demonstrate the proper techniques for applying cosmetic tattooing to eyebrows, lip-line, lip-line and blend and eyeliner on clients, and be able to answer client's questions with regard to cosmetic tattooing and have an understanding of the contraindications and complications of cosmetic tattooing.

Preference for this course is given to those with prior qualification in Beauty Therapy, Make-up Technician, Nurse, Doctor or other area with relevant training in anatomy, physiology and biology of the skin and face and those with experience in client/patient treatments. However the course is designed to provide comprehensive training even for those with limited prior experience and course content includes - **Design a Treatment Plan** (as it applies to Cosmetic Tattooing).

The trainee must not have any impediment that would prevent instruction or their ability to carry out cosmetic tattooing on models over the course of the training. This would include any physical or mental impediment that may pose a risk to the trainee, the models, or any third party. If the trainee has any doubt please discuss the matter before the commencement of the course. Trainees with potential restrictions such as, an allergic reaction to latex rubber gloves need to disclose this prior to the commencement of the course to permit alternative arrangements to be made if possible.

The trainee must have a steady hand, good vision and hand-eye coordination.

The trainee understands that Cosmetic Tattooing involves the use of an electric device to insert needles into the skin and that in some cases they may be exposed to blood, saliva and tear fluid from their clients, therefore standard precautions must be taken.

Trainees are expected to be clean and neat, and have their hair tied, pinned or netted back when performing cosmetic tattooing. Trainees are also expected to wear an appropriate protective apron or jacket and other mandatory personal protective equipment (PPE). A professional manner must be adhered too at all times during the training.

This training course is broken into five separate modules,

**Module 1** is an online theory course to be completed at trainees own pace (expect 16-32 hours), A training subscription gives the trainee 60 days access to the online training package and unlimited email support during completion of the module. In addition your training subscription includes 2 x 30 minute phone tutorials, or if you prefer a 1 hour face to face tutorial in my salon relating to the course material.

The purpose of Module 1 is to provide Aestheticians already working in the field of Beauty Therapy or those considering a career in Cosmetic Tattooing;

- An introduction to Cosmetic Tattooing.
- The theory of Cosmetic Tattooing prior to commencing the practical training.
- Home based equipment practice prior to commencing the practical training (essential).
- The knowledge required to provide general information to clients who may be considering Cosmetic Tattooing.

Upon successful completion of Module 1 students are provided a certificate of attainment and then they may if they chose enrol in module 2 to commence practical training towards their certificate/diploma.

**NB.** Successful completion of Module 1 does not certify a student to be competent to carry out cosmetic tattooing procedures. This training program is designed to be easy to use, fun, accessible, interactive and to accelerate the learning process.

**Modules 2 – 5** are practical components provided in the trainees own salon (expect 4 days). Modules 2-5 can be taken as separate components (additional costs apply).

The five course modules are broken into the following components,

1. Theory
2. Eyebrows
3. Lips
4. Eyeliner
5. Assessment.

Trainees will work on live models on days 2, 3, 4 and 5. Trainees are responsible for booking all models for their training, a minimum of 2 models per day (ideally 3). Models will be charged a \$75.00 fee by your instructor to cover the cost of procedure equipment and materials. A Minimum of 7 Models will be required for each student (assuming 1 model has all three procedures on your assessment day - Module 5).

Your salon must be equipped with a clean room with a massage/treatment table, a magnifying lamp, a small trolley or bench for set up, and a hand wash sink with hands free hot and cold taps, and of course relevant local health authority approval. All other equipment required for the training procedures is supplied by your instructor. The trainee is responsible for their own public liability and professional indemnity insurance during practical training sessions and insurance is highly recommended.

### **Assessment**

**Module 1** - will be in the form of self directed online questionnaires at the end of each chapter and a written test containing short answer and multiple choice questions at the end of Module 1 (also completed online and sent to me for assessment).

**Module 2-5** - Trainees will also be assessed throughout the training on their knowledge and ability and on their practical skills on a live model on day 5.

Trainees will either be deemed **Competent** or **Not Yet Competent** (NYC). If a trainee is deemed to be NYC they may ask to be re-evaluated at anytime in the next 12 months following training. If the trainee requires further training and supervised work on live models to be deemed as Competent there may be additional training charges.

Once you have completed your formal training additional information is required about the outcome of your initial unsupervised procedures before your certificate/diploma can be awarded (Before and After photographs, client notes and questionnaires and client feedback).

Each trainee is encouraged to purchase a Training kit. The kit will have the basics so that the trainee will be able to complete all the required self directed practice sessions in Module 1 using 3D practice pads. The kit contains a Deluxe Bella Dragon Machine that is ideal for the trainee to continue using once they begin cosmetic tattooing as a profession.

**Each Training Kit contains the following;**

- Bella Dragon Luxury Kit Machine x 1,
- 2 prong sterile disposable needles x 5
- 3 prong sterile disposable needles x 5
- 5 prong sterile disposable needles x 5
- 7 prong sterile disposable needles x 5
- Sterile disposable Small Needle Caps x 10
- Sterile disposable Large Needle Caps x 10
- Sterile disposable Machine Sleeves x 20
- Sterile disposable Transmission Shafts x 2
- Pigment Stand x 1
- Disposable pigment pots small x 10
- 3D Eyebrow practice pad x 1
- 3D Lip Practice pad x 1
- Disposable pigment pots large x 10
- Assorted Pigments x 3
- Packet Disposable practice gloves.
- Sterile Gloves x 2 pairs
- Gauze packets
- Sterile Dressing Packs x 2
- Small Alcohol wipes x 2 strips
- Large finger cots x 10
- Sharps Container x 1

During **Modules 2-5** an order form for supplies will be included so the trainee can purchase any additional supplies they require prior to commencing cosmetic tattooing as a profession.

**NB.** Additional fees will apply if additional practical training days are required.

Payment is required as per the following;

\$ 550 – For provision of Module 1 including, support, a 1 hour tutorial, and final assessment.

\$ 500 – For Training Kit (Required for practice sessions during Module 1).

\$1500 – When booking for practical training (Module 2-5).

\$3000 – Balance paid on day 1 at commencement of practical training.

Additional fees may apply for locations outside of the Melbourne Metro Area (Modules 2-5).

After completion of Module 1 Modules 2-5 can also be taken consecutively as individual components, a certificate will be awarded upon successful completion of Module 2 (Eyebrows) and Module 3 (Lip-line & Blend) and upon successful completion of Module 4-5 a Diploma in Cosmetic Tattooing is awarded. Fees for taking the course via individual components are as below;

Module 2 (Eyebrow certificate, 1 day)	\$1400.00
Module 3 (Lip-line & Blend certificate, 1 day)	\$1400.00
Module 4-5 (Diploma in Cosmetic Tattooing, 2 days)	\$2200.00
